 The Board also completed its annual self-assessment and confirmed the 2024-2025 meeting schedule

The Board also received a presentation on the then-draft Indigenous Engagement Strategic Plan and hosted a dinner recognizing former Board members and welcoming new members.

At the September meeting, the Board approved:

- Audited Statement of Expenses for the Healthcare Professional Training and Retention
   Project for the period of April 1, 2022 to March 31, 2023
- 2023-2024 Terms of Reference and Annual Work Plans for the Board of Governors and its Standing Committees
- President's Performance Review and Compensation

At the September meeting, the Board also received updates on:

- The University's Top 10 Risks, as well as an update from the Internal Auditor, including her findings from her recent audit of Big Research Projects
- Pension and endowment fund performance
- Student enrolment
- Academic Workforce Demographics

The Board also heard a presentation on the "Cypress Astronomy Outreach Program," a new initiative of the EYES program.

The Board will be having a retreat in late October, and will have its regularly scheduled meeting in December.

Following the report, Senators were invited to ask questions. Discussion followed and included an update on the University's budget process and the University's current financial situation, which has greatly improved with increased enrolments.

# 10. Administrative Reports

# 10.1 Fall 2023 Enrolment Report, For Information, Appendix IV, Pages 22-24

J. D'Arcy, Registrar, presented the report and highlighted five-year enrolment trends, population segments, and the top nations for international recruitment.

Following the report from J. D'Arcy, Senators were invited to ask questions. Discussion followed and included:

- Opportunity to advocate to the provincial government for additional funding for the post-secondary sector
- Increase in graduate student credit hours

- The possibility of tuition differentials for out-of-province students in Canada, as exists in other parts of the country

All questions were addressed by management.

#### 11. Presentation

- 11.1 "Indigenous Engagement Strategic Plan," presentation by L. Campbell, Associate Vice-President (Indigenous Engagement)
  - J. Keshen introduced L. Campbell to the University of Regina Senate.

After the presentation, discussion followed. Topics of discussion included:

- Indigenous studies courses for students and the pros/cons of requiring all students to take a mandatory course
- Opportunity for the University of Regina and First Nations University of Canada to pursue further reconciliation efforts, and be leaders in this regard
- Ensuring reconciliation is considered in all decision making processes
