## EXECUTIVE OF COUNCIL Report from the Council Agenda Committee

Item for Decision

**<u>Subject</u>**: Update Section 3.4 of the Council Rules and Regulations

**MOTION: THAT** the Council Agenda Committee recommends a new clause be added to Section 3.4 Membership and Terms of Office of the *Council Rules and Regulations*, as described below.

"In the event that a Council committee experiences the resignation of a committee member or a member who takes leave for a part of the member's allotted term, the Committee Chair may after consultation with the committee member request that the Council Nominating Committee find a replacement either for the remainder of the resigned member's term or for the duration of the period that a member is on leave. Replacements would conform to the criteria of membership outlined in that committee's terms of reference in Section 5 of the *Council Rules and Regulations*, by using names (if any) of those who volunteered for the Committee membership at the time of the last call for membership or if need be a new call for volunteers. The Council Nominating Committee may propose these replacements with a motion brought to Executive of Council at its next meeting."

**Rationale:** The rationale is concerns from CCAM and CCB that member resignations and leaves have left these committees often unable to reach quorum. The previous Chair of CCAM, Leanne Groeneveld asked at the last Council meeting if there is any way the Agenda Committee could make a rule change that would give the Nominating Committee a mandate to replace members temporarily or permanently.

**Items for Decision** 

Subject: Update the Council Committee on Academic Mission's Terms of Reference

MOTION 1: THAT the Council Committee on Academic Mission recommends to the President that number five of their Roles and Responsibilities be updated to read: To take responsibility for Academic Unit Review process as set forth in the Academic Unit Review policy and for reporting to Executive of Council and Council, as required.

MOTION 2: THAT the Council Committee on Academic Mission recommends to the President that the order of the Roles and Responsibilities be updated as follows below.

Background and Description: below are the Roles and Responsibilities with the tracked changes:

#### **Council Committee on Academic Mission**

As a voice of Council on the academic mission of the University, the Council Committee on Academic Mission shall recommend reports to Council on matters relating to the academic structure of the University (i.e. Faculties, Academic Units, affiliations or federations) and advise the President on matters that relate to academic planning, programs, academic unit reviews, and university strategic planning.

#### Membership:

8 members of Council, with no more than 2 members representing a Faculty or Academic Unit

2 students, appointed by URSU and GSA, respectively

Ex officio: Provost and Vice-President (Academic) & Vice-President (Research)

Resource: Provost and Vice-President (Academic) office

#### Roles and Responsibilities:

- 1. To review, assess and prepare recommendations for the President on the University progress on the strategic plan and to provide such reports regularly (no less than once per year) to Council and Executive of Council.
- 2. To review and make recommendations to the President on academic planning and programming.

- To take responsibility for AUR process as set forth in the AUR policy and for reporting to Executive of Council and Council, as required.
- To participate, on Council's behalf, actively in the creation of future University strategic planning, reporting back to Council as required.
- To consult regularly with the Council Committee on Budget for continuity and effective collaboration.
- 5. To review and make recommendation on the process for Faculty and Academic Unit reviews, receiving reports, and reporting to Executive of Council and Council, as required.
- 6. To report and recommend to Council on matters relating to the academic structure of the University (i.e. Faculty, Academic Units, affiliations or federations)

Rationale: The Council Committee on Academic Mission (CCAM) approved changes to their Roles and Responsibilities at their 6 October 2016 meeting. CCAM felt the current wording of item five of their Roles and Responsibilities (To review and make recommendation on the process for Faculty and Academic Unit reviews, receiving reports, and reporting to Executive of Council and Council, as required.) did not fully and clearly identify their role in AURs. CCAM members agreed to update the wording to: To take responsibility for AUR process as set forth in the AUR policy and for reporting to Executive of Council and Council, as required.

CCAM members also agreed that item five, as updated, be itemized higher to visually signify its level of importance. Members agreed to move item five to item three; item three becomes four; and item four becomes five.

# REPORT TO EXECUTIVE OF COUNCIL January 25, 2017 FROM THE COUNCIL COMMITTEE ON UNDERGRADUATE ADMISSIONS AND STUDIES

#### 1. ITEMS FOR APPROVAL

The Council Committee on Undergraduate Admissions and Studies met on January 10, 2017, and has approved the following curriculum, program and policy changes, and hereby recommends them for approval.

#### 1.1 Faculty of Arts

#### Motion 1: Bachelor of Arts Honours - Admission

To revise the admission requirements for all Bachelor of Arts Honours majors, except for those in Geography and Psychology, by replacing the requirement of "completion of, or registration in, 60 credit hours, including the Arts Core Requirements" with a requirement that students must "complete 30 credit hours, including 9 credit hours in the chosen major," as outlined below.

Effective date: 201720.

#### 9.9.2 BACHELOR OF ARTS HONOURS (BA HONS)

A BA Honours program is one that allows more specialization than is possible in the BA. It is designed for students who wish a deeper insight and more intensive training in their subject of special interest and who are able to meet the higher standards set. Students interested in entering an honours program should consult the head of the department concerned as early as possible in their academic programs, so that the program of studies may be planned in conformity with the requirements of the proposed honours program. Students are allowed to count a maximum of 48 credit hours of 100-level courses 16 introductory courses towards the program, see §9.7.4.

#### 9.9.2.1 Requirements

The BA Honours program consists of a minimum of 120 credit hours and must include the following:

- All of the BA core requirements.
- A requirement of 51 to 66 credit hours in the major as determined by each department, including a minimum of 12 credit
  hours at the 400 level in not fewer than 3 courses. Students should check the calendar entry of consult with the department
  concerned for specific requirements.
- An honours paper, a program of honours courses, and/or a comprehensive oral or written examination. Students should consult with the department concerned for specific requirements.

#### 9.9.2.2 Application Procedures for Honours Programs

Requirements for admission to Honours programs are outlined in §9.3.3.1. There is a formal application procedure for the Honours programs; application forms are available from the Arts Student Services Office and College Registrars or on the web at <a href="https://www.uregina.ca/arts/student-resources/choosing-program/honours-programs.html">www.uregina.ca/arts/student-resources/choosing-program/honours-programs.html</a>. Rationale: There is concern that the existing honours regulations are too restrictive and stifling student interest in pursuing honours degrees. For example, under the existing system many students with honours potential don't consider entering the program until well into in their 3rd year of studies. At this time, some discover that they are missing some key courses to complete the honours and when weighing their options between taking just 2 more semesters to graduate with a regular BA, or taking these 2 semesters plus additional semester(s) to take the required honours courses, some decide that the honours is not worth it. Further, we believe that if students are encouraged to enter the honours program earlier in their studies, they may have a higher self-motivation to maintain their honours students earlier in a student's studies, they may be able to provide more guidance to these students to ensure that they get the courses they need in a timely manner.

Note that the proposed revisions do not change the standards for students to graduate with an honours degree (PGPA of 70% and major GPA of 75%).

#### **Motion 2:** BA Honours Major in Geography

To create a calendar entry for the Geography Honours requirements as outlined below. **Effective date: 201720.** 

#### 9.17.2 BA HONOURS MAJOR IN GEOGRAPHY

Admission to the Geography Honours Program requires the following:

- Program GPA of at least 70%
- Major GPA of at least 75%
- · Completion of the Faculty of Arts Core Requirements, and
- · Completion of, or registration in, at least 60 credit hours

#### (end of Motion 2)

**Rationale:** Members of the department of Geography and Environmental Studies believe the current requirements serve well the needs of its Honours students.

#### Motion 3: BA Honours Major in Pyschology

To create a calendar entry for the Psychology Honours application requirements as outlined below.

Effective date: 201720.

#### 9.27.2 PSYCHOLOGY HONOURS APPLICATION PROCEDURE

Application to the Psychology Honours Program requires the following:

- Program GPA of at least 70%;
- Major GPA of at least 75%;
- Completion of at least 60 credit hours;
- Completion of all Arts or Science Core Requirement courses (depending on whether registered in the BA or BSc program, respectively);
- Completion of the Honours Program Application Form (provided on the Department of Psychology website);
- A letter of intent (as described on the Department of Psychology website); and
- Unofficial copies of all undergraduate transcripts.
- A student must have successfully completed Statistics in Psychology (PSYC 305) by the 31<sup>st</sup> of August prior to commencing the
  honours program; failure to meet this requirement will void the student's acceptance into the Psychology Honours Program, and
  the student will need to re-apply in a subsequent semester.

Applications for the Psychology Honours Program must be submitted to the Department of Psychology by February 1st of the calendar year in which the student intends to enrol in the honours program. The application process for the Psychology Honours Program is competitive, and admission into the program is not guaranteed.

Refer to §9.9.2.1 for BA Honours graduation requirements and to §16.9.2 for BSc Honours graduation requirements.

**Rationale:** Psychology has established a competitive application process for the Honours Program and the Honours Thesis course, which will now be combined into a single application, to be reviewed by the Department of Psychology.

#### Motion 4: Department of Geography and Environmental Studies – Human Geography

To revise the BA Major and BA Honours major in Geography to make Human Geography courses the majority of those that satisfy the GEOG course requirements, Effective date: **201720**.

**Rationale:** The Department of Geography and Environmental Studies is implementing additional course requirements into the BA Major and BA Honours Major in Geography to help differentiate the BA Human Geography programs from the BSc Physical Geography programs. As it stands, students could theoretically complete a BA in Geography taking mostly physical geography courses; the updated requirements will ensure that students are taking human geography courses alongside physical geography course electives. The requirements will also provide greater structure to help students plan out their BA major and BA Honours major programs.

#### **Motion 5: Cree Language Studues Minor (First Nations University of Canada)**

To revise the Cree Language Studies Minor programs as follows. Effective date: 201720.

**Rationale:** CREE 215 and 330 have be deleted as we have no capacity to teach them, so no students will be able to access them in the foreseeable future. Renumbering of these Syllabics courses has already been accomplished, and moving them to replace CREE 215 as the option for CREE 225 appropriately places two literacy-based courses as options within the minor. Additionally, it places them in a position that allows the CREE minor to be more comparable to the NAK/DAK/DENE minors which do not and cannot have courses in Syllabics (these programs only have the 225 option).

**Rationale:** CREE/SAUL 325 (Translation) is a literacy-based requirement, whereas its replacement by CREE/SAUL 340 (Oral Tradition) from the archived oracy-based program allows for an increase in the oracy requirements within the degree. CREE/SAUL 340 had previously been part of the general CREE/SAUL Language Studies degrees, but only retained in the now archived oracy-based programs. This restores its place in the remaining, general degree programs.

Again, following the minor, this introduces an important course in Culture and History to our language programs as we recognize the symbiotic nature of language and culture.

This is housekeeping following the change which moves our literature in Translation courses from the HUM designation to INDL. In the minor, this is paired with the appropriate INDG Culture and History course, but in the major both will be required.

**Rationale:** SAUL 215 and 330 will be archived as we have no capacity to teach them, so no students will be able to access them in the foreseeable future. Renumbering of these Syllabics courses has already been accomplished, and moving them to replace SAUL 215 as the option for SAUL 225 appropriately places two literacy-based courses as options within the minor. Additionally, it places them in a position that allows the SAUL minor to be more comparable to the NAK/DAK/DENE minors which do not and cannot have courses in Syllabics (these programs only have the 225 option).

Once appropriate INDL sections have been created for Nakota, Dakota and Dene, these will be added as options for the INDG course in these programs as well.

All together these changes will bring the CREE and SAUL minor programs closer in line with the minors for NAK/DAK/DENE, and also allow us to move towards creating a compatible INDL Minor for Canadian Indigenous languages beyond the Saskatchewan border.

Rationale: This matches the change made to the CREE/SAUL minors in Motion 3. The renumbering of CREE/SAUL 330 to 230 is a previously approved change, and the position of the course in the major is being changed to allow this course to act as a literacy-based option to CREE/SAUL 225 (Transcription), making room for the addition of the appropriate INDG Culture and History courses. With the recent establishment of the LING 280 Language Documentation course, we add this as an option to the renamed LING 230 (Survey of Canadian Indigenous Languages) to allow for choice among Linguistics courses between a general survey and hands-on practicum. Following other changes to the languages and linguistics programs (e.g. the archiving of the oracy programs and a number of elective options, the renumbering of the Syllabics and Literature in Translation courses, etc.) the remaining CREE and SAUL major programs require modifications. We have re-established the Oral Tradition (340) course - historically a requirement in the origbinal general degrees and the now archived Oracy programs - as an important part of degree which builds on the INDL 240 (formerly HUM) requirement. We have also added in the appropriate INDG Culture and History course (as with the minors) and added in the new Language Documentation (LING 280) course as an option.

#### **Rationale:**

• This is housekeeping, as we have recently deleted LING 200. LING 100 has long superceded LING 200 as the main introduction to linguistics.

- This is housekeeping following recent changes in the FRN programs.
- This allows for even more indigenous language content within our Linguistics programs.
- This also allows for the potential addition of more indigenous language content within our minor program (while both LING 220 and 230 are requirements within the major).
- This both includes some housekeeping changes required by the previously approved changes in Linguistics (LING 200, FRN 236) and opens up the options for students to include a stronger concentration in Indigenous Linguistics within their programs.

#### **Rationale:**

- The new NSLI Certificate and required courses NSLI 200, NSLI 300, NSLI 310, and NSLI 330 were approved in 2015-2016, culminating with approval by the University of Regina Senate on June 6, 2016.
- The NSLI Certificate is offered by the Faculty of Arts and CCE, all of the NSLI courses will be taught by Luther College (except possibly for cross-listed courses), and administrative support for the program is provided by the Voluntary Sector Studies Network at Luther College. The collaboration among these units in offering the NSLI Certificate is outlined in an MOU among Arts, CCE, and Luther College.
- As noted in the table above, there are seven NSLI courses in total. NSLI 200 is required of all students. The decision about which of the other NSLI courses would be required for the NSLI Certificate, and which would be electives, was made on the basis of ranking the importance of these courses through extensive consultation with the nonprofit/voluntary sector. However, in this consultation all of the NSLI courses were considered to be important choices for certificate students. In other words, while the placement of three NSLI courses in the electives rather than the required list was on the basis of relative ranking, there was little actual difference in the ranking score. Another factor in the decision was the hope that having just four required courses that would be taken by all NSLI students would foster an on-campus community of NSLI Certificate students.
- The proposal outlined below to change the Certificate program is made on the basis of
- the demonstrated student interest in the program and the possibility of cross-listing some of the "elective" NSLI courses with other existing university courses, and thus the opportunity to offer the "elective" NSLI courses sooner
- The reality that students will be completing the certificate program according to their individual schedules either as a standalone program or to complement their degree program (and therefore the realization that an on-campus community of NSLI Certificate students should be fostered in other ways)
- The benefit of increased flexibility that will allow students to tailor their certificate program to their needs and career goals
- Assisting students with timely program completion, and
- further consultation with the nonprofit sector that indicates support for the proposed changes.

#### 11.15.5 FOUR-YEAR SECONDARY BED (INDIGENOUS EDUCATION) PROGRAM

The Indigenous Education Department offers an 8-semester BEd Program. Secondary Teacher Education students must select a major and a minor area of study in the BEd. The Indigenous Education program allows students to select an Indigenous Studies major, delivered by First Nations University of Canada. Students may select other majors from offerings in the Faculty of Education (§11.11.3). Minor areas of study may be selected from those available in the Faculty of Education (§11.11.4).

Students are required to meet established standards to proceed to each of the second, third, and fourth years of the program. These standards include appropriate professional development. A student must have an average of at least 70% in the major to proceed to internship. The number of students in the secondary program is limited to those admitted through a selection process. Student records will be reviewed for admission to EIND 200, EPS-200, EIND 350 EPS-350, and internship. Students require a PGPA of 65.00% for graduation.

#### 11.15.5.1 Field Experience Components

The Indigenous Education program includes student teaching experiences in several semesters of the program including EIND 100, EPS 100, EIND 200 EPS 200, EIND 350, EPS 350, EIND 305 and EFLD 400.EIND has a requirement for practicum in a reserve school in Saskatchewan. In EFLD 400, students have a sixteen week school placement in an urban, rural or reserve school.

#### 11.15.7 SECONDARY BED AFTER DEGREE (BEAD) (INDIGENOUS EDUCATION) PROGRAM

An approved university degree which includes at least 24 hours of approved courses in a school teaching major and 18 hours of approved courses in a school teaching minor is required for entrance.

The program normally requires completion of a minimum of 60 credit hours. Additional courses may be required to complete requirements for the major or minor areas of study.

In addition to satisfying major and minor requirements, students must complete <u>EIND 100</u> <u>EPS 100</u> and <u>EIND 200</u> <u>EPS 200</u> prior to the pre-internship semester. While students may, under special circumstances, take these two courses concurrently, they are urged to take EPS 100 either as part of their first degree, or before they begin the BEAD program. Appropriate professional development and an average of 70% in the major are normally required for entrance into internship.

The Indigenous Education Department offers courses needed to complete the major or the minor in Indigenous Studies. Other majors or minors may be selected from those available in the Faculty of Education program offerings (see §11.11.2 and §11.11.4).

Students may need to take prerequisite courses toward fulfilling requirements in the major or minor areas.

#### 11.15.7.1 Field Experience Components

The Indigenous Education BEAD program includes student teaching experiences in each semester of the program including <u>EIND 100</u> <u>EPS 100</u>, <u>EIND 200</u> <u>EPS 200</u>, <u>EIND 350</u> <u>EPS 350</u>, EIND 305 and EFLD 400. EIND has a requirement for practicum in a First Nations school in Saskatchewan. In EFLD 400, students have a sixteen week school placement in an urban, rural or First Nations school.

#### 11.15.7.2 Cultural Component

The Indigenous Education Department's courses emphasize First Nations content and processes. Cultural components are integrated throughout the program with a specific off-campus cultural camp component offered.

Applicants who have attempted 15 credit hours or more of approved post-secondary education with a UGPA between 55 - 59.99% will be admitted to the Certificate in Media, Art, and Performance (Qualifying) program.	

#### (end of Motion 38)

**Rationale:** The establishment of a qualifying program within the Certificate in Media, Art, and Performance is seen as a recruitment/retention initiative and is being developed to provide a supported entry point into MAP for certain students who might not otherwise be admitted to the faculty. The Certificate in Media, Art, and Performance ladders into all BA & BFA programs offered by the Faculty of Media, Art, and Performance; students who successfully raise their average to a minimum of 60% may choose another program within the Faculty and will not be penalized but will be at the same stage in their program as direct entry students.

Currently the various Faculties across the University of Regina have a variety of thresholds ("attempted credit hours of approved post-secondary education") for incoming transfer students<sup>1</sup>. Reducing this requirement will provide some transfer students with more flexibility in selecting an academic home at the University of Regina.

<sup>1</sup> For example: 12 (EENG), 15 (ARTS, BUS, NURSING), 24 (KHS, SCI, SW)

The qualifying program will allow the faculty to identify students who require additional transitional and academic support (including the requirement to successfully pass MAP 001 – Strategies for Success) It will be easier to monitor the academic progress of students enrolled in the qualifying program and to gauge subsequent academic progress.

#### **Motion 39: Probation and Discontinuance**

That the following be added to the section 14.5.2 (Probation and Discontinuance) at the beginning of 14.5.2.2 Faculty Regulations. **Effective date: 201720** 

**Note:** The current regulations would then be renumbered from 2 to 4.

## 14.5.2.2 Faculty Regulations

- 1. Students in the Faculty of Media, Art, and Performance are expected to maintain a PGPA of 65.00%. After a student has completed 15 credit hours, the Faculty will assess their academic performance. Those whose PGPA falls below 65.00% will be placed on faculty probation (faculty probation does not appear on official transcripts). Students who are placed on faculty probation will:
  - a) Have an academic hold place on their account restricting them from future registration.
  - b) Must schedule and attend a mandatory advising session with the student program advisor and the department head.
  - c) Agree to the probationary contract that is created during the above mentioned advising session. The contract may include: a restriction on the number or level of courses a student might register in, require attendance at workshops offered by the student success center (or other academic supports), on-going advising/counselling until the student clears faculty probation.

For the next 15 credit hours undertaken, the student will be on Faculty-level Probation. During this time they may take any courses but it may be recommended that they re-take specific classes. If, the student has successfully raised their PGPA by the end of the probationary period to above 65%, they will be removed from faculty probation. If the student has not successfully raised their PGPA to above 65% they will remain on faculty probation for 9 more credit hours. If the student successfully raises their PGPA by the end of the second probationary period then they will be removed from faculty probation. If a student has not raised their PGPA above 65% after being on faculty probation for 24 credit hours, they will be RTD from the Faculty of Media, Art and Performance.

Faculty probation refers only to a student's PGPA. Students must also satisfy the university regulations around Academic probation and to be aware of the graduating requirements of their particular program.

#### (end of Motion 39)

**Rationale:** To avoid being placed in university-level academic probation, (5.13.4.1), an undergraduate student must maintain a minimum undergraduate grade point average of 60.00% or higher. The problem for MAP is that the GPA (and PGPA) required for graduation is 65.00% (or higher). Generally this is not a problem, but there are students who "skate" between 60% and 64.99% and while the Student Program Centre can catch many of these students there is

- a) little that can be done except repeatedly telling students they will not graduate
- b) requires, unfairly, the student program advisor to be aware of all underperforming students and where their averages might be situated.

This motion addresses this current loophole.

## **Centre for Teaching and Learning Innovation**

The CTLI is a place for the discussion, collaboration, and advancement of teaching and learning at the University of Regina. It is designed to provide support, guidance, and resources to faculty and instructors in their endeavors to facilitate learning, guide development of critical thinking and problem solving skills, and convey essential skills such as literacy and numeracy.

The CTLI is a centre of the University of Regina reporting to the Provost's Office via the Associate Vice-President (Academic and Research) with advisory supports from the Dean, Faculty of Education and University Librarian, and one additional representative of Deans' Council. The CTLI Chair works closely with staff in the Distance and Distributed Learning unit, most particularly the Instructional Designers and UR Courses specialists, at the Centre for Continuing Education, to ensure that all avenues for course delivery are accessible to faculty and instructors.

The CTLI Chair will lead a consultative process to create a comprehensive vision of teaching and learning to guide the direction and priorities of the Centre. The process to create this vision will begin by September 2017, requiring consultation and development of the vision to be a priority of the Chair. Furthermore, this vision will constitute the preliminary stages in development of a new Strategic Plan for Teaching and Learning which will be collaboratively created and collegially approved, effective Fall 2018. The vision will:

- Provide a bold statement of purpose that engages and energizes the University community
- Create a clear, coherent, and actionable plan to inspire innovation in teaching and learning
- Emphasize the importance of the scholarship of teaching and learning in our institution
- Support Faculties and Academic Units to develop discipline-specific outcomes and frameworks of teaching excellence (whether embedded in criteria documents or as separate guidelines referenced in criteria documents)
- Clearly and concisely signal the importance of and commitment to high-quality teaching

The primary responsibilities of the CTLI Chair are to ensure that existing resources are effectively leveraged to support and encourage high-quality teaching, support innovative SoTL activities that can be incorporated across disciplines, and provide high-quality services to faculty and instructors.

In addition to an annually scheduled suite of services and programs, the CTLI and its Chair will demonstrate high impact practices of teaching and learning at the University of Regina by being responsive and accessible. This includes feedback on teaching, development and delivery of specially designed programs responsive to faculty and instructor needs and institutional priorities (such as Indigenizing our curricula), provision of targeted resources and supports that focus on Strategic Plan for Teaching and Learning objectives, offering supports for nominations and applications to internal and external awards and funding, and commitment to demonstrating and teaching others to apply post-secondary teaching techniques at the leading edge of applicable, high impact approaches for UofR.

The CTLI Chair is a leader who devotes her/his energy to demonstrating high impact teaching and learning, as well as one who provides exceptional leadership and management of CTLI staff, and accessible supportive programming for University faculty and instructors. The newly visioned CTLI brings continuity, diversity, innovation, and sustainability to the Centre as well as aligning the Centre to the 2015 – 2020 University Strategic Plan, *peyak aski kikawinaw*.

In recognition and respect for the leadership of the Faculty of Education in teaching, learning, mentorship and innovation in K-12 and post-secondary education, and given its explicit commitment to scholarly teaching and the scholarship of teaching and learning, the CTLI Chair will work closely with the Dean, Faculty of

Education. Appropriately, the Faculty serves as a place of institutional prominence regarding the importance placed on high quality teaching and learning. As such, it is uniquely positioned within the institution to support the CTLI Chair in his/her mandate.

#### **CTLI Staff and Resources**

- University Chair in Teaching and Learning
  - o A renewable 3-year term that includes a stipend per the URFA CBA
  - Chair activities will constitute 80% of the faculty member's contributions and time commitments to the University and her/his Faculty or Academic Unit
  - o Reports to the Associate Vice-President (Academic and Research)
  - Specific workload assignment is developed annually in consultation with an advisory board consisting of the AVP (Academic and Research), Dean, Faculty of Education, University Librarian, and one additional representative of Deans' Council
  - Is responsive to the Teaching and Learning Champions via decisions and directions determined within the Teaching and Learning Advisory Group
- 13 Teaching and Learning Champions placed in each Faculty and Academic Unit
  - Renewable 2-year terms with contributions to CTLI recognized by the member's home Faculty Dean or Academic Unit Director primarily within the research and service contributions of the member
  - Access to annual SoTL research and dissemination fund at discretion of CTLI Chair based on alignment with CTLI and institutional priorities, Faculty/Unit discipline-specific outcomes, and other criteria established in collaboration with the oversight committee
  - Responsive to the CTLI Chair as members of the Teaching and Learning Advisory Group and providing at least one workshop session plus 50 hours of service to the CTLI per academic year
  - Arts, Business Administration, Centre for Continuing Education, Education, Engineering & Applied Science, Graduate Studies and Research, JSGS, Kinesiology + Health Studies, La Cité, Media, Art and Performance, Nursing, Science, Social Work
  - o Performance of CTLI annual objectives included in the AIF requires negotiation with, and agreement of, the relevant Dean or Director
    - Accountability for performance of duties and accepted responsibilities falls to faculty member or instructor and is within the purview of the relevant Dean or Director
- 1 APT educational development specialist
  - o Develops and delivers programming per the priority activities as directed by the CTLI Chair
  - o Reports to the CTLI Chair
  - o Ideally holds a PhD and has expertise and experience in developing, leading, and guiding high impact teaching and learning methodologies, pedagogies, and approaches
  - Works closely with IDs in CCE and has experience with distance, distributed, and/or hybrid course development and delivery
  - Provides daily oversight of CTLI functions, responsiveness to requests, and scheduling of activities
  - o Is responsible for maintaining knowledge and expertise at the leading edge of high impact teaching and learning understandings
- ½ CUPE staff
  - Support and coordinate program delivery
  - o Maintain online presence and annual schedule of events
  - o Coordinate the calendars for the CTLI Chair and APT ED specialist

## Additional services and supports provided by:

- 1 Fellow (graduate student) funded through the Graduate Student Scholar program
- President's Teaching and Learning Scholars at 20 hours of contributions per year
- Awards Recipients at one workshop (or equivalent) in the year following receipt of the award
- Liaison Librarian from the University Library assigned to support the work of the Centre and its Chair
- Coordinated liaison role for Teaching Preparation Centre Coordinator, Faculty of Education

#### **Physical Location**

LY610: Reorganized space, including glass wall and improved segregation of office and classroom activities

- Small, dedicated CTL classroom inside the Library
- Access to unencumbered University spaces, such as ED 114 and LI 215
- Leveraging the Teaching Preparation Centre for larger workshops and access to resources

## **Budget Management**

The CTLI budget is allocated to and managed by the Provost's Office. The AVP (Academic and Research) serves as the budget signing officer.

**Subject:** DRAFT Field Trip Policy

## **Background and Description:**

During the fall 2016 semester, one instructor had built a field trip into her course syllabus. The class turned out to include someone who was wheel-chair bound. The instructor, to her credit, arranged for special transportation for this student. The cost was covered, on an ad hoc basis, by the relevant Faculty. This incident, when brought to the attention of Deans' Council, made all the deans aware that the University has no standard procedure for approving the inclusion of field trips in course syllabi and for managing the associated costs and risks. The draft policy is intended to fill that void.

The essence of the proposed policy is that any faculty members or staff planning to incorporate a field trip into their syllabus or co-curricular programming get the prior permission of their dean or equivalent for this. The very request for permission will trigger the procedures needed to ensure that the relevant costs and risks will be acceptable to the units involved and that the students will have signed the necessary liability waivers.

# University of Regina Draft Policy for Field Trips

#### Introduction

The University of Regina takes great care in ensuring that all faculty, staff and students participating in field trip experiences in Canada and internationally are fully aware of all the risks involved. Because Field trip activities can expose participants to significant risks to their health, safety or well-being, the University has developed the following policy and procedures to guide faculty, staff and students participating in field trips.

#### **Definition**

The term "field trip" refers to any group activity which requires travel by students beyond the campus of the University of Regina. Such travel may be for academic purposes or for activities organized and recommended, or supported, by University of Regina faculty and/or staff.

#### Scope and Application

This policy and related procedures will guide the participation of faculty, staff and students at the University of Regina who participate in University field trips.

#### 1.0 Faculty, staff and/or students travelling for Field Trips within Canada

Faculty members must receive permission from their Dean, or equivalent, before adding any field trip components to their course syllabi. (Faculties can request that a charge be added to course fees to cover the cost of field trips; see policy GOV-010-020 for details.) For unforeseen circumstances, last-minute accommodations can be made, but only with the prior approval of the relevant Dean or equivalent. This is to ensure that group transportation and disability accommodations, if required, will be available and financially feasible. Prior to travel, faculty members and/or staff who have obtained prior approval for a field trip must complete the Travel Authorization Request Form (Appendix 1) and submit a copy to Financial Services. The Travel Authorization Request Form must be accompanied by a completed Travel Liability Waiver Form (Appendix 3) for each student who will be participating in the field trip. Copies of the completed Travel Liability Waiver Forms will be kept within the relevant Faculty or Department.

Faculty and/or staff members are responsible for arranging, and finding financing for, group transportation to the site of the Field Trip. Students may choose not to use the group transportation provided and arrange their own means of transportation instead. But they must do so at their own risk and expense.

## 1.1 Faculty, staff and/or students travelling for Field Trips internationally

Faculty members must receive permission from their Dean, or equivalent, before adding any international field trip components to their course syllabi. (Faculties can request that a charge be added to course fees to cover the cost of field trips; see policy GOV-010-020 for details.) For unforeseen circumstances, last-minute accommodations can be made, but only with the prior approval of the relevant Dean or equivalent. This is to ensure that group transportation and disability

accommodations, if any, will be available and financially feasible. Prior to travel, faculty members and/or, staff must ensure that there are no restrictions placed by the Government of Canada on travel to the destination country. Prior to travel, faculty members and/or staff must also complete the Travel Authorization Request Form (Appendix 1) and submit a copy to Financial Services. The Travel Authorization Request Form must be accompanied by a Safety Plan (Appendix 2) and by a completed Travel Liability Waiver Form (Appendix 3) for each student who will be participating in the field trip. Copies of the completed Travel Authorization Form and Travel Liability Waiver Form must be sent to the UR International Study Abroad Office. All participants must ensure that they have obtained international travel insurance prior to departure.

#### **Appendices**

- 1. The Travel Authorization Request Form is a Financial Services document that also includes a Risk Assessment portion pertaining to all faculty, staff and sports teams. Health, Safety & Wellness can assist with performing comprehensive risk assessments.
- The Safety Plan is a form developed by UR International and Health, Safety & Wellness for International Travel.
- 3. The Travel Liability Waiver is a form developed by UR International for local and international travel.
