Enrolment continues to be positive. Spring/Summer enrolment was up 3.5% over last year. As well, Fall 2018 enrolment was up 1.9%, as of the first day of classes. This is our eighth year of record enrolments.

Convocation is coming up. The honorary degree recipients are Dr. Ray Cleveland and Dr. Elizabeth Bryce. Dr. Cleveland is a long time professor in history and with the Lifelong Learning Centre. Dr. Bryce is a microbiologist and alumna who is a leading infection expert in Canada.

Two professors have been elected to the prestigious Royal Society of Canada. Dr. Raymond Blake and Dr. Peter Leavitt. Congratulations were given to Dr. Blake and Dr. Leavitt. A reception to celebrate their achievements will be held following Executive of Council in the upcoming months.
