4. Remarks from the Chair

Promise "Max" Chukwudum, a University of Regina student has been missing since 17 November 2018. If anyone hears anything regarding this student's disappearance, please contact Regina Police Service.

The Research Office just released its latest edition of Discourse Magazine. The magazine emphasizes the quality of research the University of Regina is producing. Featured on the cover is Simon Granovsky-Larsen who has examined violence in Guatemala.

The University of Regina has welcomed two new Canada Research Chairs, Dr. Michelle Coupal and Dr. Jennifer Gordon. Dr. Coupal's research is in Truth and Reconciliation, and Dr. Gordon's is in Biopsychosocial Determinants of Women's Mental Health.
