#### 3. Business Arising from the Minutes

J. D'Arcy, Registrar, reported on the University's current English Language Proficiency (ELP) requirements. L. Castellanos, AVP (International), reported that she is engaging members of the campus community in discussion about ELP requirements (including specific bands), GPA admission requirements, as well as the add/drop deadline.

Discussion followed and included:

- Faculty members' recent experiences in the classroom
- The difficulty of ensuring student success with the long registration period, and students' arrival after the start of classes

It was agreed that T. Chase, Provost and Vice-President (Academic), would ensure further study of these concerns, with an update provided at the next Executive of Council meeting.

Further discussion included:

- The typical process for motions to be brought to Executive of Council
- The ability for Executive of Council to refer items to Council Committee(s) for consideration
- The preference for more formal or informal meeting governance, as well level of formality in noting or recording discussion and recommendations of Executive of Council

#### 4. Remarks from the Chair

In keeping with the Indigenization commitment in the University's strategic plan, the Chair acknowledged that the University is located on Treaty 4 and Treaty 6 territory and the traditional homeland of the Metis.

Dr. Timmons offered the following remarks:

A private service was held last weekend for Promise "Max" Chukwudum. This is a heartbreaking situation for all. Thanks to all for their support.

The President's Community Award was awarded last night to Chili for Children. It was a very emotional presentation, as everyone was so appreciative. We are looking for ways to provide more support to this organization, which feeds Regina children who may otherwise have little.

The State of the University Address was hosted today by the Regina Chamber of Commerce. The presentation was a departure from previous years and instead focused on challenges in leadership.

The budget process is underway. The focus this year will be on teaching, donor relations and revenue generation. A budget forum will be held on January 29<sup>th</sup>, and a short town hall meeting will be held prior to the forum.

As was reported, the athletics department faced challenges with athlete eligibility. Since then, a number of controls have been implemented to mitigate these risks going forward.

Our re-commitment to reconciliation document was completed in December. This has been two years of work for the working group. This is a very important document as it ensures we have tools for education and reconciliation.

UR Respect is currently being rolled out to various areas. This is part of our continuing efforts to ensure our university is a safe and respectful place for all.

Dr. d. Gregory, Dean, Faculty of Nursing spoke to recent discussions surrounding health services on campus. Discussions are ongoing.

Dr. T. Chase, Provost and Vice-President (Academic) spoke to the changes under consideration for the Centre for Teaching and Learning (CTL). A retirement will occur in one of our Associate Vice-President positions; this position will be restructured to oversee teaching and learning, as well as aspects of the current portfolio. Staffing of the CTL in 2019-20 is part of current budget discussions, which include input from the Council Committee on Budget.

Following the Chair's remarks, Executive of Council was invited to share any further information or discussion items. Discussion followed and included:

- Feedback on the current operations of the University of Regina Bookstore. There have been some struggles with obtaining textbooks for students registered in classes
- Consideration of possible alternative to an AVP position related to teaching and learning
- The possibility of revising our Indigenous acknowledgement from a passive acknowledgement to a more "active" statement
- Prime Minister Justin Trudeau's attendance at the University of Regina for a recent town hall and the significance of this event especially for many of our international students. Dr.
   Timmons noted that political leaders of all stripes are invited to the University to speak and engage with our campus community
- Re-thinking health care to include mental health and well-being, and increasing health promotion on campus
