#### 3. Business Arising from the Minutes

#### 3.1 English Language Proficiency Requirements Task Force

L. Castellanos, AVP International, provided an update on the work of the English Language Proficiency task force. The task force will recommend that English Language Proficiency (ELP) requirements for undergraduate admissions increase to align with other comprehensive universities in Canada. The recommended changes will be considered by the Council Committee on Undergraduate Admissions and Studies, Executive of Council and Senate.

Discussion followed. Topics of discussion included:

- The impact on international recruitment
- The possibility of changes to academic requirements for international admissions in the future

#### 4. Remarks from the Chair

In keeping with the Indigenization commitment in the University's strategic plan, the Chair acknowledged that the University is located on Treaty 4 and Treaty 6 territory and the traditional homeland of the Metis.

Executive of Council observed a moment of silence in memory of Dr. Dominic Gregorio and Joe Fafard.

President Timmons offered the following remarks:

The 10<sup>th</sup> annual Inspiring Leadership Forum was held on March 6<sup>th</sup>. This year's forum included Elizabeth Smart, Cheryl Strayed, Jann Arden and Mira Sorvino. Over 800 individuals attended the event and it has now become one of the University's signature events.

The 5<sup>th</sup> annual Prairie Kitchen Party will be held on May 10<sup>th</sup>. The event supports students in financial need, everyone is encouraged to attend.

On March 21<sup>st</sup>, the "You Belong Here" event was launched. This is an important campaign to ensure that the University is a safe and respectful place for all.

The Federal Budget was recently announced and there are some positives in the budget for students, including international study and work opportunities, scholarships and the lowering of interest for student loans. Additionally, there was support for research projects including TRIUMF and CIMHVR.

The Provincial Budget was announced and we received a 0% increase from last year. The University budget team is working to limit tuition increases while investing in priority areas.

The University of Regina and the University of Regina Faculty Association (URFA) have reached a tentative agreement for academic staff members. Thank you to both bargaining teams for this important work.

The University of Regina Women's Basketball team reached the national finals. While there were tough losses and injuries, these women were great ambassadors for the University.

Thank you to those who put their names forward to serve on Executive of Council. All new members have been informed, and the slate of members for 2019-2020 will be posted shortly.

A call for volunteers to Council's Committees has been issued; please consider putting your name forward for the various committees.
