4. Remarks from the Chair

In keeping with the Indigenization commitment in the University's strategic plan, the Chair acknowledged that the University is located on Treaty 4 and Treaty 6 territory and the traditional homeland of the Metis.

Executive of Council observed a moment of silence in memory of Noel Starblanket and Nelson Wagner.

President Timmons offered the following remarks:

The University of Regina and the University of Regina Faculty Association (URFA) have ratified an agreement for academic staff members. Thank you to both bargaining teams for their work in negotiating a new collective agreement.

The 2019-2020 budget is still being developed. Thank you to everyone's work on this, including the Council Committee on Budget. The University is working towards a balanced budget. The priorities have remained the same throughout the budget process with a focus on new faculty members, support for the Centre for Teaching and Learning (CTL), the Central Testing Facility, and donor relations.

College Avenue Campus is all but complete with Darke Hall being our largest outstanding piece. An announcement will be made on April 25th regarding funding from the federal government. The University is still working on additional funding to ensure the success of this project.

The University's "You Belong Here" campaign was launched last month, as well as a new program "4 Seasons of Reconciliation" developed with First Nations University of Canada. All university faculty, staff, and students are encouraged to complete the program.

The 5th annual Prairie Kitchen Party will be held on May 10, 2019. The funds raised for this event support the URSU Emergency Bursary Fund. Everyone is encouraged to attend.

Spring Convocation will be occurring on Wednesday, June 5th, Thursday, June 6th, and Friday, June 7th. This year's Honorary Degree Recipients are Barb Ryan, Jon Ryan, Eric Peterson, Renu Kapoor, and Gordon and Jill Rawlinson.

Dr. David Malloy, Vice President (Research) has been appointed Principal of King's University College, Western University. Dr. Malloy has been a faculty member at the University for 30 years. Thanks were given for Dr. Malloy's years of service to the University.

The NSERC Discovery Grant competition has closed and the University of Regina was very successful. Twenty-six grants were issued, plus additional supplements. Our success rate was nearly 75%, which is the highest in recent memory. Congratulations were given to all those who were successful.

- 2. Increase the IELTS Academic (International English Language Testing System) minimum score requirements to no band less than 6.0, the overall band score will remain at 6.5., effective 201930.
