4. Remarks from the Chair

In keeping with the Indigenization commitment in the University's strategic plan, the Chair acknowledged that the University is located on Treaty 4 and Treaty 6 territory and the traditional homeland of the Metis.

President Timmons offered her remarks, including:

The decision to leave the University of Regina was not an easy one. The timing was right both professionally and personally. A search for University of Regina's eighth President will begin in 2020. In the interim, Dr Thomas Chase will serve as President and Dr david Gregory will serve as Provost and Vice-President (Academic).

The decision by the Woodrow Lloyd Lecture Committee to invite Canadian poet George Elliott Clarke was not supported by all communities, and brought back painful memories. Following Professor Clarke's withdrawal from the lecture, the healing process has begun to rebuild relationships. This is an ongoing process.

Thank you for the discussions at the December 6th Council Meeting around sustainability and carbon offsets. There are significant points to discuss regarding sustainability on campus.

Enrolment is again positive for the Winter 2020 term. For the first time in the Winter term, enrolment has exceeded 15,000.

President Timmons invited d. Gregory, Dean, Faculty of Nursing, to provide an update on the Student Wellness Centre, which is being created to offer primary health care and health promotion for students on campus.

President Timmons invited G. Grandy, Dean, Faculty of Business Administration, to provide an update on the University of Regina's success at JDC West 2020.
