# 4. Remarks from the Chair

Dr Chase offered his remarks including:

Fall 2020 in-person and remote classes, while challenging, are going well. The University was informed that Proctortrack, our remote exam proctoring service, had a security breach. No personal student information was affected during this breach.

Winter 2021 course delivery planning is underway. The In-Person Course Assessment Team (IPCAT) has evaluated faculty proposals for in-person courses. Information regarding those courses will be communicated shortly.

Return to the workplace discussions are underway. The University is taking a cautious approach to this question, and will consider provincial rates of infection prior to any changes to current protocols.

Thank you to everyone for your continued hard work during this time. Your dedication and commitment to students is apparent. Your patience and understanding during this time is appreciated, as we are all working under unusual circumstances.

Following the Chair's remarks, Executive of Council was invited to share any further information or raise questions for discussion. Council raised questions and provided input related to the timing of employees' return to work.

**Moved that** all admissions to the current Bachelor of Arts in Theatre and Performance Major, Acting Concentration and the Bachelor of Arts, Theatre and Performance Major, Design/Stage Management Concentration be suspended indefinitely, effective 202130.

A question was raised regarding the decision to suspend these traditional programs and create a devised performance program. R. Staseson and S. Whalley outlined the need for a non-traditional program, with the Bachelor of Fine Arts in Devised Performance being a first of its kind in Canada. This program will provide students more exposure to writing and stagecraft and enable their involvement in new paradigms such as fringe work, etc. This new program also resulted from consideration of the most recent academic unit review completed in the Faculty of Media, Art, and Performance.
