The meeting was called to order at 2:30 p.m. by the Interim President and Vice-Chancellor, Dr Thomas Chase.

In keeping with the University's commitment to reconciliation, the Chair acknowledged that the University is located on Treaty 4 and Treaty 6 territory and the traditional homeland of the Métis.

3. Business Arising from the Minutes - None.

4. Remarks from the Chair

Dr Chase offered his remarks, and requested members of the Senior Leadership Team to also provide information:

The Spring/Summer 2021 term has temporarily moved to remote learning due to high case count in Regina and the increase of variants of concern (VoC) in the province. This decision will be reassessed on or before May 10th.

Our thoughts are with those who are impacted by the current COVID-19 crisis in India.

The April 30th town hall will focus on the COVID-19 virus in the province and implications for the University, an update on campus' deferred maintenance, and environmental sustainability initiatives.

The WHL abbreviated season is coming to a close. The University and Luther College hosted approximately 250 players and staff since February 2021. Throughout the season, everyone was kept healthy and safe.

The University of Regina Board of Governors meetings will occur next week. The comprehensive budget plan, as well as any changes to tuition and fees, will be discussed and approved at this meeting. Communications will be sent to the University community following the Board meetings. In addition, there will be a town hall on May 7th to discuss the budget.

A sector wide announcement will be made in coming weeks announcing plans for the Fall 2021 term. The Fall term will be transitional where we hope to see many more students on campus, with a return to a much more typical Winter 2022 term.

The Chair invited J. D'Arcy, Registrar, and d. Gregory, Interim Provost and Vice-President (Academic), to provide additional details on enrolments and student initiatives:

- Enrolment for the Spring/Summer 2021 term is trending similar to previous years. Currently the Fall 2021 term is seeing an increase in headcount and credit hours. This is likely to settle out somewhat over coming months.
- The University of Regina is the first Saskatchewan post-secondary institute to join MyCreds, a digital credential wallet developed by the Association of Registrars of the Universities and Colleges of Canada. Currently students are able to access their transcripts and confirmation of enrolments. Over the coming months services will increase to include digital parchments, confirmation of graduation, immigration documents, etc. Thanks were extended to the Registrar's Office team for this initiative.

Following the Chair's remarks, Executive of Council was invited to share any further information or raise any questions for discussion. Discussion included:
