- Range of microcredential types, including both non-credit and credit (many of which can be "stackable" or "ladder" into diplomas or degrees)
- Coordination in our approach to development of microcredentials to ensure the University is not duplicating efforts
- Currently no standardized national or international definition of microcredential
- Ability to use microcredentials to reach Indigenous communities and new Canadians
- Approval process for credit microcredentials to ensure proper academic oversight
