The meeting was called to order at 2:31 p.m. by the Interim Provost and Vice-President (Academic), Dr david Gregory.

3. Business Arising from the Minutes

3.1 Graduate Advanced Training and Entrepreneurship (GATE) Centre – Proposal, Appendix I, Pages 2-15

A. Douai presented the Graduate Advanced Training and Entrepreneurship (GATE) Centre proposal to Executive of Council, and noted the further consultations that had been undertaken.

Douai - McNutt

Moved that Executive of Council approve the proposal for a Graduate Advanced Training and Entrepreneurship (GATE) Centre.

Discussion followed. Topics of discussion included:

- Inclusion of only certain Indigenous organizations in the proposal documents risks omission of some that would be relevant to the Centre
 - It was agreed that within the proposal, the identification of specific organizations would be removed in favour of a more generic approach
- Revenue and expense projections, and recognition that programming will be developed based on graduate student interest and skill requirements
- Alignment with available funding sources supporting graduate students, including from Mitacs
- Potential fee may be considered in the future and would need to be competitive in the graduate school landscape
- GATE will be a faculty-based Centre, with oversight provided in accordance with the Research Institutes and Centres Policy
- The Centre's programming will be available to all graduate students, and will assist in international graduate student recruitment

The question was called on the motion.

4. Remarks from the Chair

Dr Gregory offered the following remarks, including:

Spring/Summer and Fall 2022 enrolments are down compared to the previous year. Although these are early results, we will continue to monitor.

Today is provincial budget day. The University is in its second year of stable funding, which amounts to a reduction as other expenses rise. The 2022-2023 budget is under development and will be presented at the April Board of Governors meeting.

d. Gregory is participating in student engagement sessions with the President including related to international and Indigenous student experiences, teaching and learning experience, mental health supports, and equity, diversity and inclusion. Throughout the sessions, a common theme was the impact professors have on student lives.

A signing ceremony with Campion College and Luther College was held on March 17th. The renewal of the Guidelines for a Working Academic Relationship highlight the value our relationship with the Federated Colleges.

A sustainability action plan from the President's Advisory Committee on Sustainability (PACS) will be completed shortly.

Planning and development of the Office of Experiential and Service Learning is well underway for the Fall. The Office is currently seeking to hire an academic lead to develop the programming that will be offered.

Following Dr Gregory's remarks, Executive of Council was invited to share any further information or raise any questions for discussion. d. Gregory confirmed the continued availability of rapid antigen test kits for students during the final exam period.

All questions were addressed by Dr Gregory.

Faculty of Science Admission Requirements – Revisions

The following two motions were moved as an omnibus motion.

Cheng - Farenick

Moved to update the post-secondary admission requirements to the Faculty of Science and the Faculty of Science Qualifying program such that the post-secondary admissions category applies to any student who has attempted a minimum of 15.0 credit hours, effective 202230.

Moved to update the minimum admissions average for Post-Secondary applicants to be calculated based on a maximum of the student's most recent 30 credit hours of approved courses. In cases where the AGPA on the most recent 30 credit hours of approved courses is less than 60%, admission to the Science Qualifying program will be considered based on a minimum AGPA of 60% on all approved post-secondary courses, effective 202230.

6.2.4 **UR International and Enrolment Services**

English Language Proficiency Test - Duolingo English Test

Moved that the Duolingo Online English Test with a minimum score of 110 be extended as an accepted approved test of proficiency in English for undergraduate admissions, on a temporary basis for the 2022-2023 academic year (May 1, 2022 to April 30, 2023). This test is currently being used for the 2021-2022 academic year (July 1, 2021 to April 30, 2022).
