Dr Keshen provided an update on recent activities, including:

- Re-opening of Darke Hall and the celebrations of the revitalized space
- The University was the recipient of a 2022 Regina & District Chamber of Commerce Paragon Award for Environmental Excellence
- The University's performance in the 2022 Times Higher Education Impact Rankings
- Update on the 2022 employee engagement survey conducted in April
- Creation of Project Resilience to support students affected by war or other forms of political violence
- Funding from the provincial government to support the Cypress Hills Field Station
- Update on the searches for the Vice-President (Administration) and Provost and Vice-President (Academic)
- 2022-2023 University of Regina budget is being finalized and will be presented for recommendation to the Board of Governors

Dr Keshen engaged Executive of Council in a collegial discussion on equity, diversity, and inclusion (EDI) initiatives at the University of Regina. Topics of discussion included:

- Connection between EDI and the UN Sustainable Development Goals, especially related to principles of participation/inclusivity
- Need to address the Truth and Reconciliation Commission of Canada Calls to Action, and acknowledgment that prioritization may be required due to fiscal constraints
