#### 4. Remarks from the Chair

Dr Keshen provided an update on recent activities, including:

- The Spring Convocation ceremonies will be held in person on June 8<sup>th</sup>, 9<sup>th</sup>, and 10<sup>th</sup>. We look forward to having our graduating students on campus to celebrate their achievements
- An update to the masking requirements will be announced shortly
- UR Days will be concluding. UR Days was hosted in Weyburn, Yorkton, Swift Current, Regina and Prince Albert
- The University is expanding its dual credit opportunities for students in high school
- Prior Learning and Assessment Recognition (PLAR) is being formalized for the Royal Regina Rifles and the 15 Wing Moose Jaw
- The University is experiencing an increase in applications from international students
- Academic and administrative units are being urged to provide greater scrutiny when hiring for various unfilled positions
- The Confucius Institute underwent an administrative review. The results of the review will be shared with the Senior Leadership Team (SLT) in coming weeks
- Search for the Provost and Vice-President (Academic) and Vice-President (Administration) are proceeding well. Public presentations for the Provost and Vice-President (Academic) are currently being held. A position description for the Vice-President (Administration) has been posted
- A number of different events have been held on campus in the past few weeks including the UR
   Leading wrap up, the Cougars/Rams Varsity Sports Awards, Campus Beautification Day
- Thank you to all who have donated to the Big Hearts campaign
- A Town Hall will be held on June 23<sup>rd</sup>. An update on the University's institutional identity project will be shared, in addition to the results of the employee engagement survey

In response to a question, the President confirmed that hiring supported by research or external funding would not be impacted by the increased oversight requirements.

#### Graduate Record Examination – Suspension

A question was raised regarding the rationale for the continued suspension. It was clarified that the GRE requirement was initially suspended due to examination access difficulties during the pandemic, but the suspension has continued in other Canadian psychology programs post-pandemic. Applicant quality and quantity has not decreased as a result of this suspension and it has allowed the University of Regina to remain competitive nationally.
