The meeting was called to order at 2:32 p.m. by the President and Vice-Chancellor, Dr Jeff Keshen.

In keeping with the University's commitment to Reconciliation, the Chair acknowledged that the University is located on Treaty 4 and Treaty 6 territory and the traditional homeland of the Métis.

3. Business Arising from the Minutes – None.

4. Remarks from the Chair

Dr Keshen provided an update on recent activities, including:

- Attendance at the Cowessess First Nation Traditional Pow Wow and the Treaty 4 Gathering
- Joined the ta-tawâw Student Centre, and faculty and staff of the University of Regina and its federated colleges in a smudge walk and prayer service to honour the victims of the James Smith Cree Nation and the community of Weldon, Saskatchewan
- miyo-wîcîwitowin Day will be held on September 29th at Mosaic Stadium to recognize the National Day for Truth and Reconciliation
- Creation of an Indigenous strategic plan, facilitated by the AVP (Indigenous Engagement)
- Update on executive searches
- Meetings with the Government of Saskatchewan and City of Regina
- Update on Fall 2022 enrolments and efforts to recruit students
- Work on a comprehensive academic plan will commence shortly
- Launch of the Centre for Experiential and Service Learning (CESL), with an opening event planned for November
- Establishment of a Sustainability action plan and creation of a Sustainability office
- Continued work on dual credit opportunities for high school students in the province
- Change in title to Dean for the University Librarian, Director of Centre for Continuing Education, and Director of La Cité universitaire francophone

Dr Keshen addressed the proposed reduction of the Library acquisitions budget and the restoration of funding through investments from the Vice-President (Research) and the Research Services Fund.

- Need for collaborative consultation when considering reduced access to journals

- Recognition that transition "out" of the pandemic will prove challenging
